Unless otherwise specified in the respective trades/sections, the timber for all trades shall be as specified in Carpentry & Joinery.

#### A6. Cement

Cement having SLS 107 or equivalent Approved by Engineer.

#### A7. Trade Name

Where trade names, brands and / or catelogue or equipment may be used, Provided that the characteristics of type, quality ,appearance, finish method of construction and / or performance is not less than specified and provided also that approval is first obtained.

#### A8. Method of Measurement.

This Bill of Quantities has been provided generally in accordance with:-

- (a)The principles of the Standard Method of Measurement for buildings works in Sri Lanka. (SLS 573:1982)
- (b) The S.M.M. issued by the quantity Surveying Section. Departments of Building August 1980

#### A9. Rates

Rates for all items shall be inclusive of the following:

- (a.) All supply of materials, labour, plant, Scaffolding, waster, Incidental Materials, fixing media, Cartage, Hoisting, Fitting and fixing Complete.
- (b.) Providing holes, chasing ets. as directed for electrical Installation and all other services and making good as the same as and when such installations are provided
- (c.) Providing samples speciments ets for such items of work as required.
- (d.) All overhead preliminary expences and profit except where otherwise stated.
- (e.) Testing of all buildings materials.
- (f.) Furnishing monthly 3 sets of photography for the buildings under construction form three location dentified by the Engineer.
- (g) Providing stable access (Temporary Stair case) Externally from ground floor to 1 st and 2 nd floor level to transport materials, labourer & etc.

#### A10. Measurements:-

Tenderers are to note that the measurement are taken absolutely NET unless otherwise stated and they must, therefore, allow in their prices for all straight cutting and waste, laps ,etc through out even though not specifically mentioned.

#### A11. Descripancies:-

Any descripancies in drawings Specifications, Bill of Quantities or any other documents should be brought to the notice of the Employer before tendering.

#### A12. Payments:-

Payments shall be made on actual quantity of work carried out at the site as per Contract. The quantities given in the bill of quantities are approximate.

Attention of the tendered is drawn to the requirements of contract, the specifications and any other Particulars of the tender It is the tenderers responsibility to see that his prices include for and any complying with all the requirements of the conditions of contract and any outer documents whether specifically referred to in the bill of quantities or not.
